Via Garden State Parkway/Route 280 Eastbound: Take Parkway North or South to Exit 145 Route 280 Newark/Harrison. Pay toll and follow signs for Route 280 East (Newark/ Harrison). Head eastbound on 280 (stay in one of the two lanes to your right). Proceed for 2.7 miles. Immediately after the Stickle Bridge take Exit 16 Harrison. Make a left hand turn at the 1st Traffic Light onto Cleveland Avenue proceed through two lights at the third light make a left onto North F.E. Rodgers Blvd.(formerly No.4th St). Proceed for 2 lights. The law office is on the right hand side on the corner of North F.E.Rodgers Blvd. and William Street.

Via NJ Turnpike/Route 280 Westbound: Take the New Jersey Turnpike to Exit 15W (Kearny/The Oranges) after paying the toll follow signs for Route 280 westbound. After proceeding approximately 3/4 miles take Exit 16 (Harrison) off of Route 280. At the 1st Light Make a Right onto North 5th St. At the next Light (1 block) make a Left onto Bergen Street. At the next Light (1 block) make a Right onto South F.E.Rodgers Blvd. Proceed 7 lights on F.E. Rodgers Blvd. to the intersection of North Frank E. Rodgers Blvd. and Williams Street. The law office is on the right hand side on the corner of North F.E.Rodgers Blvd and William Street.

Via Route 1 & 9, Route 21 Northbound: Take Route 1&9 to Route 21 northbound and proceed on Route 21 (McCarter Highway) continue past the New Jersey Performing Arts Center, and make a right hand turn onto Bridge Street (corner landmarks Mobil Gas Station and Seabra's (Don's) 21). Proceed on Bridge Street/Harrison Avenue through 6 lights at the 7th light make a left hand turn onto North Frank E. Rodgers Blvd. (formerly North 4th Street), proceed North three lights to the Intersection of North Frank E. Rodgers Blvd. and Williams Street. The law office is located at the corner. Metered parking is available on North Frank E. Rodgers Blvd. (the meters only accept quarters). 2-hour parking is available on side streets.

Via Route 21 Southbound: Take Route 21 South (McCarter Highway) immediately after Bridge Street (Mobil Station/Seabra's 21) make a U-turn by using Lombardy Street (see map). Make a left onto Route 21 (McCarter Highway) .At the next light (Bridge/Rt 21) , make a right onto Bridge Street go over the bridge onto Harrison Avenue proceed through 6 lights at the 7th light make a left hand turn onto North Frank E. Rodgers Blvd. (formerly North 4th Street), proceed North three lights to the Intersection of North Frank E. Rodgers Blvd. and Williams Street. The law office is located at the corner. Metered parking is available on North Frank E. Rodgers Blvd. (the meters only accept quarters). 2-hour parking is available on side streets.
